**ORDER**

Dated: 15/08/2015

WHEREAS, the institution i.e. Seth Moti Lal Teacher Education College, In front of Rani Sati Mandir, District- Jhunjhunu-330001, State- Rajasthan was granted recognition by the NRC vide Order No. F.NRC/NCTE/F-3/RJ-368/8465-8474/ dated 13.08.2005 for conducting B.Ed. course of one year duration with an annual intake of 100 (One Hundred Only) students.

AND WHEREAS, the recognition granted to the institution for B.Ed. programme was withdrawn by the NRC vide Order No. F.NRC/NCTE/F-3/RJ-368/2010/16373-16378 dated 08.02.2010 on the following points:-

- The deficiencies communicated through letter F.No.NRC/NCTE/RJ-763/142 Meeting / 6010 dated 9 July 2009 still exist.

AND WHEREAS, the Institution preferred an appeal dated 17.03.2010 to the Council, NCTE, New Delhi under section 18 of NCTE Act, 1993 against the aforesaid order. The Council vide order dated 05.05.2010 rejected the appeal and NRC's order dated 08.02.2010 was confirmed.

AND WHEREAS, the institution filed Writ Petition No. 370/2010 in the Hon'ble High Court of Delhi at New Delhi. The court had passed an order dated 26.05.2010 in which the decision of NRC to withdraw the recognition of the institution duly endorsed by the Appellate Authority was set aside by the Hon'ble High Court of Delhi. A letter conveying the decision of the Court to continue the recognition of the institution for the academic session 2010-11 was issued on 20.10.2010. In view of the observation of the Hon'ble Court that the order of NRC withdrawing the recognition was not reasoned one and was contrary to provision of Section 17 of the NCTE Act 1993, the reply of institution in response to the Show Cause Notice observed by NCTE in its 142<sup>nd</sup> meeting held on 14-16 June 2009 has been considered afresh, in the light of the VT Report and observation of the CD taken at the time of the inspection in the 182<sup>nd</sup> meeting of NRC held from May 15-21, 2011 and it was decided to issue Show Cause Notice to the institution under section 17 of the NCTE Act 1993. Accordingly, a show cause notice was issued to the institution on 07.06.2011.

AND WHEREAS, reply received from the institution in response to the aforesaid notice on 04.07.2011 was considered by the NRC in its 189<sup>th</sup> meeting held from November 24<sup>th</sup> to 28<sup>th</sup>, 2011 and following observations have been made:-

- The institution should be asked to submit the list of approved faculty members (approved by the University (for B.Ed.), SCERT, Director, School Education (Primary to class of STC), Bikaner, as has been mentioned by the institution in its reply dated 04.07.2011, para D
- Copies of the letter should be sent to the Registrar of the concerned University w.r.t. B.Ed. and Director, SE w.r.t. STC for information and necessary action.
- Accordingly, letter was issued to the institution on 10.01.2012.

AND WHEREAS, the reply dated 09.02.2012 received from the institution in response to the show cause notice dated 10.1.2012 was considered by NRC in its 209<sup>th</sup> meeting held from 26<sup>th</sup> to 28<sup>th</sup> December, 2012 and the Committee decided that the recognition for the said course be withdrawn under provision of section 17 of NCTE Act, 1993, if any, submitted by the institution be returned. Accordingly, the recognition of the institution was withdrawn vide NRC order dated 28.01.2013 on the following points:-

- The college has not submitted the approval letter of the concerned affiliating university with regard to the selection of individual teachers of B.Ed. programme of Seth Moti Lal Teachers Education College. Recognition letter of the institution by the affiliating university shall not be treated as university approval of individual teachers recruited by the institution.
